Flat Monthly Interface fees concerning ATHEX are ZERO (0) to ATHEX Members and DSS Operators for the <u>first</u> ATHEX-Net User Node.

The traded value fee is VAT free, is calculated on the value of each executed trade (ad valoren), is indicated on the client trade ticket

that is issued by the Member As Exchange fee, is payable per trading day by the Member, is received by the CSD on T+1,

is invoiced every 15 days to the Member and is normally passed on to the client by the Member.

The order fee is VAT free, is calculated for each business day, is payable per trading day by the Member, is received by the CSD on T+1

and is invoiced every 15 days to Member. Normally, it is not passed on to the client.

The ODL order fee is VAT free, is calculated for each business day, is payable per trading day by the Member, is received by the CSD on T+1 and is invoiced every 15 days to Member. Normally, it is passed on to the client as Exchange fee if the client uses order routing.

on 1+1 and is invoiced every 1s days to Member. Normally, it is passed on to the client as Exchange fee if the client uses order roll it is calculated every Quarter, based on the total Traded Value executed by the Member over the Quarter. It is equal to 1/4 of 1

of the corresponding category of Table 1. It is invoiced and is paid by the ATHEX Member after the end of each Quarter.

The file with all the ODL orders entered by the Member on a daily basis is uploaded to each Member, each business day

The total Traded Value for the Quarter and the calculation is indicated on the invoice sent to the Member.

- Invoicing of ATHEX Members occurs every 15 calendar days (1st and 15th of each month).

Each invoice includes detailed information for each business day on the daily traded value, the number of orders, the number of ODL orders
the unit price for each charge and the sums calculated.
