

**€€ NEW MANDATE: Hellenic Republic ("Greece") – New EUR 10-year Benchmark €€**

"The Hellenic Republic, rated Ba3 / BB / BB / BB (Moody's stb./S&P pos./Fitch pos./DBRS pos.), has mandated Barclays, Commerzbank, Eurobank, Morgan Stanley, Nomura and Societe Generale as Joint Lead Managers for a new 10 year Euro-denominated offering of Reg S Cat1, 144A eligible, CACs benchmark bonds to be issued in dematerialised registered form carrying a June 2032 maturity. The syndicated transaction will be launched in the near future, subject to market conditions. ICMA stabilisation rules and regulations apply."
