

Press Release

The Stock Markets Steering Committee of Hellenic Exchanges - Athens Stock Exchange met on October 23rd, 2014 and examined the prerequisites, as provided for in the ATHEX Rulebook, regarding the classification of listed shares in Trading Categories, in the regular semi-annual review.

No transfer among Trading Categories resulted from the examination of the companies' data for the period 01/04/2014 – 30/09/2014.

Consequently, the listed companies on October 23rd, 2014, per Trading Category, appear in the table below:

Furthermore, the Stock Markets Steering Committee of Hellenic Exchanges - Athens Stock Exchange, during its session on October 23th, was informed of the increase in the par value of the shares of the company "**ENVITEC S.A. - TECHNICAL & ENVIRONMENTAL PROJECTS**" from € 0.60 to **€ 0.69** per share. The start date of trading of the existing shares under their new par value of € 0.69 per share is set on **October 30th, 2014**.

- The acquisition of a market making license for the HELEX Member «**EUROBANK EQUITIES S.A.**», for market making on the shares of the listed company «**FRIGOGLASS S.A.I.C.**» and set of the start date of market making on the aforementioned shares for Monday, October 27th 2014.
- The resignation of the ATHEX Member «**NUNTIUS SECURITIES S.A.**» from the property of trading member of the ATHEX Derivatives Market.
- The resignation of the ATHEX Member «**Z.G. PORTALAKIS Brokerage S.A.**» from the property of trading member of the ATHEX Cash Market.
