Karamolengos Bakery Industry SA is a Greece-based company active in the bakery and confectionery sector. The Company is mainly engaged in the production as well as the distribution of bakery and confectionery products. Its product portfolio consists of toast bread, including crumb, rye and white bread with no preservatives or other additives; traditional bread, such as wheat bread; specialty bread, such as whole meal and rye bread; hamburger bread in various sizes; tsourekia (large bread rolls), and grated bread. Its products are mainly sold via supermarkets and other small retail shops. Karamolegos Bakery Industry SA is active in Greece via the Company's operations and through its 60%-owned subsidiary, Apollonio SA. The Company also operates in Romania through its 92%-owned subsidiary, Karamolegos Bakery Romania SA, in Popesti-Leordeni, Romania. Its production facility is located in Tzima, Koropi, Greece.
