**TECHNICAL DESCRIPTION OF VENDOR/SUBVENDOR'S  
INFORMATION SERVICES**

VENDOR/SUBVENDOR shall report at its responsibility in this Annex the following (inter alia):

**A list of services by means whereof the Information, within the framework hereof, is relayed to its corporate clients/subscribers (in any form, with or without further processing).**

For each service thereof provided by paragraph (1), the determination of the invoicing method by ATHEX, in accordance with the type of service and the relative pricing policy of the ATHEX (e.g. on the basis of devices/subscribers or the sum of gross income declared to the ATHEX by means of the relative periodical reports - statements within the framework of the provisions of Annex D).

For each service provided by paragraph (1), the particulars / data pertaining to the technological infrastructure (telecommunications, networks, computers et al.) developed and used by the counterpart for the relay of the Information to subscribers and / or SUBVENDORS. In particular, the following Information (inter alia) is requested, according to the category of the counterpart:

- 1 Brief technical description of the (technological) infrastructure thereof in Greece and / or abroad for the relay of the Information.
- 2 Brief technical description of any contacts and Agreements of co-operation with other Information suppliers (SUBVENDORS) aiming at the relay of the Information services rendered to a wider number of subscribers of other networks.
- 3 Brief description of the telecommunications / network services of national / international service providers (e.g. mobile telephony, cable TV, satellite communication, Internet, Teletext, Videotex, Audiotex and other Information service providers) used for the connection - per service provided by paragraph (1) - of the final users by means of devices of any type (computer, mobile telephone, TV receiver et al.) and / or the intermediation of other networks.
- 4 Description - per service provided by paragraph (1) - of any type of device supported as an alternative for ATHEX's Information relay.
- 5 Description - per service provided by paragraph (1) - of the "user identification codes" management system (creation / correction / removal of entries from the respective database), as well as of the user authentication and access control certification mechanisms regarding the final subscribers/devices for the use of each service.
- 6 Furthermore, the particulars (full name, post, tel., fax, e-mail) of the contact official of the counterpart shall have to be declared, as regards 1, 2 and 3 above.
