9M 2012 FINANCIAL RESULTS

Consolidated turnover € 394,9 mn. (9M 2011: € 386,1 mn.)

EBITDA € 57,9 mn. (9M 2011: € 43,2 mn.)

- INTRACOM HOLDINGS GROUP reported increase in turnover by 2,3%, increase in operating profitability (EBITDA) per 34%, positive EBIT and decrease of losses after tax and minority rights per 46%.
- INTRAKAT Group reported decrease in turnover per 13%, while maintains the higher Backlog among the Group's companies (€ 250 mn.)
- Hellas Online keeps reporting increase in turnover (7,3%), managing to withhold losses at € 12,2 mn.
- INTRASOFT INTERNATIONAL Group remains in operating profitability (EBITDA € 4,7 mn.) and significantly reduces losses in comparison to 9M 2011, even without taking into account the extraordinary events that determined the results of the previous year.
- INTRACOM DEFENSE ELECTRONICS, reporting increased turnover by 18%, remains in operational profitability, even marginal, and significantly reduces losses before tax.
