- INTRACOM HOLDINGS financial results for 2013 have been affected by provisions and impairments of assets.
- Adjusted EBITDA before provisions and impairments amounted to € 74,9 mn. EBITDA margin slightly increased versus 2012.
- Sales level retained; slight decrease of 5%.
- HELLAS ONLINE, for the first time in the FY financial statements, records a positive EBT of € 2,2 mn., and preserves high EBITDA margin of 30,5%
- The Group reported New contracts worth € 480,7 mn.
- Order Backlog as per Dec 2013 reached € 703,1 mn.
