Ms Frangou and Mr Throuvalas were appointed to the board following the proposal of MIG's shareholder IRF European Finance Investments. Mr Throuvalas also serves as the CEO of IRF. The appointment of these two members marks the involvement of IRF, as a strategic shareholder in MIG, in formulating and implementing the group's strategy.

Ms. Frangou, in her capacity as Chairman of the Board of Directors and Chief Executive Officer of Navios Group of Companies, has been consistently included, from 2010 onwards, in the Lloyd's List of 100 most influential people in the shipping industry. Navios Group comprises of three companies listed on NYSE (Navios Maritime Holdings Inc., Navios Maritime Partners L.P. και Navios Maritime



Acquisition Corporation) with an aggregate market capitalisation that exceeds USD3.1bn. Ms Frangou has also served as a member of the Board of Directors of Eurobank Ergasias and Emporiki Bank, two of Greece's largest banks.

Ms Frangou holds a bachelor's degree in Mechanical Engineering, summa cum laude, from Fairleigh Dickinson University and a master's degree in Mechanical Engineering from Columbia University.

Mr Throuvalas has been working since 1982 in the fields of Finance and Investments, having served as Chief Financial Officer of the Theoharakis Group and a board member in several companies, including among others, NIK. THEOHARAKIS S.A. (commercial company), TEODOMI AKTE (construction company; as Vice Chairman of the Board of Directors), MINETTA Insurance company, Metropolitan Hospital, Marfin Egnatia Bank and several of its subsidiaries. He has participated in the design and implementation of business plans with emphasis on financial and operational implementation.

Mr. Throuvalas studied Economics (B.A) at the University of Athens and holds a graduate degree in Economics (M.A. in Economics) from Manitoba University (Canada) having earned a scholarship from the Greek State Scholarships Foundation and the Canadian university.
