

## Notification of important changes concerning voting rights under L. 3556/2007 [1.4.2014]

Alpha Bank A.E. (the "Bank") announces, pursuant to the provisions of L. 3556/2007 and following relevant notification from Citigroup Global Markets Limited on March 31, 2014, that the company as of March 26, 2014 holds 97,000,962 voting rights corresponding to an equal amount of common, registered, voting, dematerialized shares (0.88 % of the total voting rights of the Bank) and titles representing shares ownership rights (Warrants), which if exercised in full, correspond to 527,021,986 voting rights (4.82% of the total voting rights of the Bank). As a result, the voting rights corresponding to common shares and Warrants, in case they are exercised in full, amount in total to 624,022,948 or 5.71% of the total voting rights of the Bank.
