

**Notification of important changes concerning voting rights
under L.3556/2007**

Piraeus Bank S.A. (the “Bank”) announces, pursuant to the provisions of L.3556/2007 and following relevant notification from Seth A. Klarman on July 26th 2013, that The Baupost Group L.L.C., as of July 23rd 2013, holds (indirectly) 523,580 voting rights corresponding to an equal number of common, registered, voting, dematerialized shares (0.01% of the total voting rights of the Bank) and titles representing shares ownership rights (Warrants), which if exercised in full, correspond to 306,985,407 voting rights (6.05% of the total voting rights of the Bank). As a result, the voting rights corresponding to common shares and Warrants, in case they are exercised in full, amount in total to 307,508,987 or 6.06% of the total voting rights of the Bank.
