

ANNOUNCEMENT ON THE PUBLICATION OF THE PROSPECTUS

OF EUROBANK ERGASIAS S.A.

Eurobank Ergasias S.A. (the "Bank") announces that, in accordance with the Regulation 809/2004 of the European Commission and I.3401/2005, as in force, the prospectus for the listing in the Athens Exchange (ATHEX) of the new shares resulting from the Bank's share capital increase, which was fully subscribed by way of contribution in kind from the Hellenic Financial Stability Fund, according to the resolution of the Extraordinary General Shareholders' Meeting of 30 April 2013, will be made available to the public on 11.6.2013, following its approval by the Hellenic Capital Market Commission (HCMC) on 10.6.2013.

Specifically, the above mentioned Extraordinary General Meeting resolved, among others, the increase of the share capital of the Bank through the issuance of 3,789,317,358 new ordinary shares of a nominal value of 0.30 each, in order to raise 5,839 million, subscribed by way of contribution in kind from the Hellenic Financial Stability Fund, in accordance with the provisions of 0.3864/2010 and the Act of the Cabinet 38/9.11.2012
