


**Notification of important changes concerning voting rights under L. 3864/2010  
[9.12.2016]**

Alpha Bank A.E. (the "Bank") announces, pursuant to the provisions of L.3864/2010, that Blackrock Inc., following a relevant notification as of 8.12.2016, holds indirectly as of 7.12.2016 voting rights that correspond to an equal amount of common, registered, voting, dematerialised shares, namely 5.06%, excluding those held by the Hellenic Financial Stability Fund (HFSF).  
The disclosure obligation arose due to voting rights exceeding the 5% threshold.

The voting rights are analysed as follows:
