

Notification of important changes concerning voting rights under L. 3864/2010 [29.3.2017]

Alpha Bank A.E. (the "Bank") announces, pursuant to the provisions of L. 3864/2010 that Blackrock Inc., following a relevant notification on 28 March 2017, holds indirectly as of 27 March 2017 voting rights that correspond to an equal amount of common, registered, voting, dematerialised shares above the 5% threshold of the total voting rights of the Bank, excluding those held by the Hellenic Financial Stability Fund (HFSF).
