Listings and Market Operation Committee - Athens Stock Exchange (ATHEX)

The Listings and Market Operation Committee met on December 6th, 2017 and decided the deletion of the shares of:

- **MICROLAND COMPUTERS S.A.** (GRS351003009), **HELLENIC FABRICS S.A.** (GRS219003001), and **PC SYSTEMS S.A.** (GRS381313006), which have been under suspension of trading for a period longer than six months (par.3^a, article 2.6.12. of the ATHEX Rulebook).
- **MARAC ELECTRONICS S.A.** (GRS471003012) and **COMPUCON S.A.** (GRS443003017) which are trading on the Under Deletion Category, due to annual total revenue of less than €2 mil. (par.3^b, article 2.6.12. of the ATHEX Rulebook). The suspension of trading of the shares of these companies on ATHEX will take place on **Tuesday, December 19th, 2017.**

The removal of the shares of the aforementioned companies from the ATHEX trading systems will take place on **Thursday, December 21st, 2017.**

Relevant announcements of the companies **MICROLAND COMPUTERS S.A.**, **HELLENIC FABRICS S.A.**, **MARAC ELECTRONICS S.A.** and **COMPUCON S.A.** have been posted on the ATHEX website www.athexgroup.gr. **PC SYSTEMS S.A.** did not respond to ATHEX's request to publish a relevant announcement.
