### Listings and Market Operation Committee - Athens Stock Exchange (ATHEX)

The Athens Stock Exchange, following today's session of its Listings and Market Operation Committee, announces that

- on **Tuesday, December 19<sup>th</sup>, 2017**, the **2,501,885** new common registered shares of "**EUROCONSULTANTS S.A.**" (ISIN:GRS439003005), which resulted from the share capital increase through a rights issue, will commence trading on ATHEX.

Moreover, the Athens Stock Exchange accepted

- the application of "**INVESTMENT BANK OF GREECE S.A.**" to become a Nominated Adviser of the Alternative Market of the Athens Stock Exchange (EN.A.),
- the resignation of «**DYNAMIC SECURITIES S.A.**» from Sponsored Market Access to the firm «**NORTHERN GREECE SECURITIES S.A.**»,
- the acquisition of a market making license for the ATHEX Member "**EUROBANK EQUITIES INVESTMENT FIRM S.A.**", for market making on the shares of the listed company "**INTRALOT S.A.**" and set of the start date of its obligations on the aforementioned shares for Monday, December 18<sup>th</sup> 2017. At the end of the first year, the Market Making license is automatically renewed for an indefinite period, during which the Market Making may terminate, even without an important reason, after the lapse of a 30 day notification deadline.
