The Athens Stock Exchange, following today's session of its Corporate Actions Committee, announces that the following will be implemented:

Monday, January 28th, 2019

- Commencement of trading of **163,626** new common registered shares of "[FOURLIS S.A.](#)" (ISIN: GRS096003009), following the share capital increase realized as a result of the exercise of rights to participate in a stock option plan.
