## Announcement of EYATH Group Financial Results for the year 2018

High Profitability, strong cash basis and investment in human resources

## 2018 Financial Year Overview

- O Consolidated turnover remained almost stable and amounted to € 73.03 million compared to € 73.4 million in the previous financial year, reflecting a marginal decrease of 0.51%
- O Gross profit amounted to € 30.29 million against € 30.14 million in 2017, showing a marginal increase of 0.47%.
- Profit before tax amounted to € 20.95 million compared to € 24.93 million in the previous year, showing a decrease of 15.96%.
- O After-tax profits amounted to € 14 million compared to € 16.45 million in 2018, a decrease of 14.9%.
- O EBITDA earnings amounted to € 25.48 million compared to € 29.51 million in the previous year, indicating a decrease of 13.67%.
- The company has a strong cash basis of € 71.63 million, increased by 9.85% compared to 2017.
- The share capital remains unchanged at  $\in$  40,656 million divided into 36,300,000 ordinary shares with a nominal value of  $\in$  1.12 each.
- ① The Equity of the Group stood at € 173.14 million at 31.12.2018.

The decrease in earnings is mainly due to increased personnel costs due to two staff recruitment competitions that were run by ASEP to hire 150 full-time staff. The recruitment of the staff started the second half of 2017 and was completed at the start of 2018 (personnel increase by 40%). Earnings were also affected by the impact of adopting IFRS 9 "Financial Instruments" for the estimation of impairment of trade receivables.
