

## **Notification of significant changes in voting rights according to the Law 3556/2007**

**02.07.2019** Forthnet S.A. (hereinafter “the Company”) informs the investing public of the following:

(a) according to the notification dated of 27.06.2019, which was received by the Company on 28.06.2019, Maria Ferfeli of Stelios directly held, in her capacity as a proxy of WIND HELLAS TELECOMMUNICATIONS S.A., thirty six million three hundred thirty two thousand and four hundred fifty seven (36,332,457) voting rights which are equal to 22.052% of the total amount of the Company's voting rights, in order to represent WIND TELECOMMUNICATIONS S.A. at the Company's Ordinary General Assembly held on 28.06.2019 or at any Repeat or postponed General Assembly and vote at her absolute discretion, by virtue of WIND HELLAS TELECOMMUNICATIONS S.A.'s proxy dated 25.06.2019. According to the same notification, Maria Ferfeli will cease to hold the above voting rights from 28.06.2019 upon the completion of the Company's Ordinary General Assembly or following the completion of any Repeat or postponed General Assembly.

(b) according to the notification dated of 28.06.2019, which was received by the Company on 28.06.2019, Christina Varveri of Miltiadis directly held, in her capacity as a proxy of WIND HELLAS TELECOMMUNICATIONS S.A., thirty six million three hundred thirty two thousand and four hundred fifty seven (36,332,457) voting rights which are equal to 22.052% of the total amount of the Company's voting rights, in order to represent WIND TELECOMMUNICATIONS S.A. at the Company's Ordinary General Assembly held on 28.06.2019 or at any Repeat or postponed General Assembly and vote at her absolute discretion, by virtue of WIND HELLAS TELECOMMUNICATIONS S.A.'s proxy dated 25.06.2019. According to the same notification, Christina Varveri will cease to hold the above voting rights from 28.06.2019 upon the completion of the Company's Ordinary General Assembly or following the completion of any Repeat or postponed General Assembly.

(c) according to the notification received by the Company on 02.07.2019, Crystal Almond Holdings Limited (former Largo Limited), which indirectly controls, via its controlled companies Crystal Almond Intermediary Holdings Limited, Crystal Almond S.a.rl and WIND HELLAS TELECOMMUNICATIONS S.A. (the latter holding directly), thirty six million three hundred thirty two thousand and four hundred fifty seven (36,332,457) voting rights which are equal to 22.052% of the total amount of the Company's voting rights, notified the Company that Mss. Maria Ferfeli and Christina Varveri, following the completion of the Company's Annual General Assembly on 28.06.2019, ceased to hold thirty six million three hundred and thirty two thousand four hundred and fifty-seven (36,332,457) voting rights, corresponding to 22.052% of the total voting rights of the Company.
