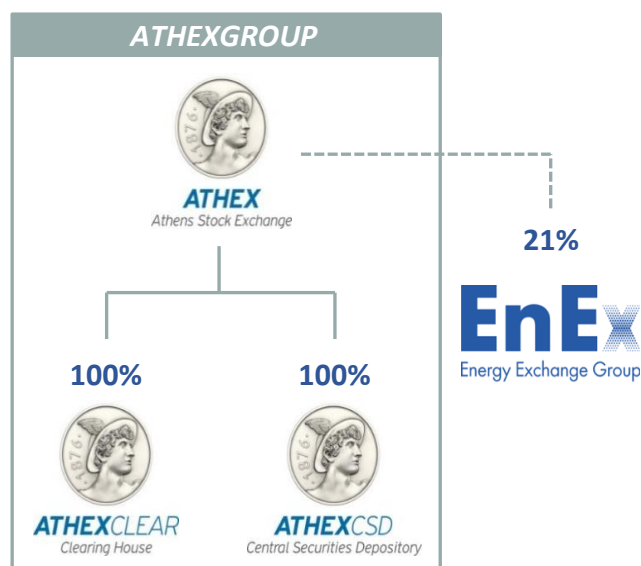

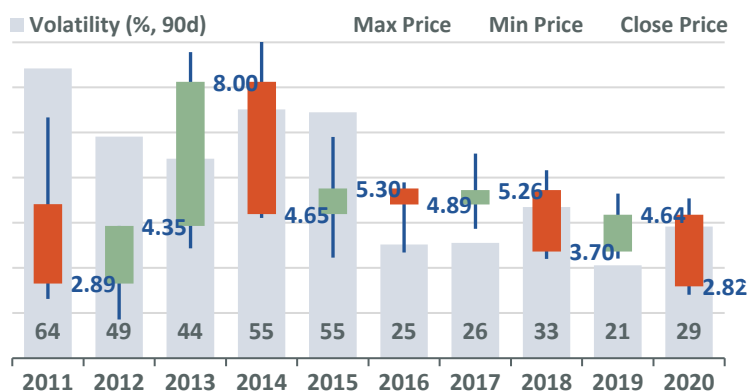
The Group also provides support services to the **Hellenic Energy Exchange** in which it holds a 21% stake.

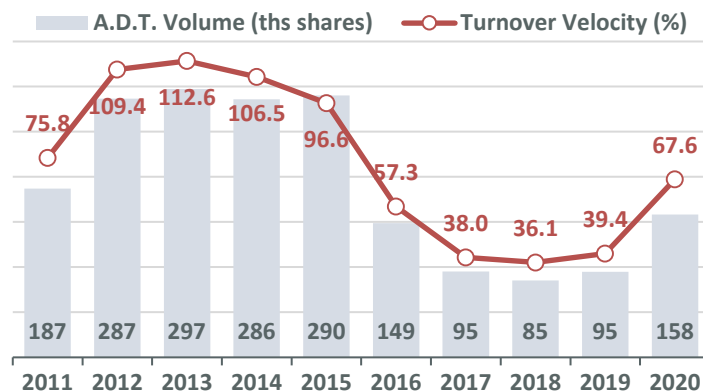
Group Structure

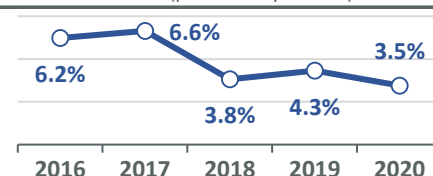
Operating Cash Flow (€ mil)
