

Share buy-back announcement

FOURLIS HOLDINGS S.A. announces in accordance with article 49 of Law 4548/2018, pursuant to the decision of the Ordinary General Meeting of the Shareholders dated 14.06.2019 and the decision of the Board of Directors dated 13.01.2020, that on 03/04/2020 purchased 4.000 own shares, at an average price of €2,7700 per share, a total value of €11.080,00.

Following the aforementioned purchase, the Company currently holds 149.064 treasury shares or 0,2866% of the total number of issued shares of the Company.
