

Announcement of disposal of own shares

Brussels, 25 May 2020, 13:00 CEST – Titan Cement International S.A. (Euronext Brussels, ATHEX and Euronext Paris, TITC) announces, in accordance with article 8:6 of the Royal Decree of 30 April 2019 implementing the Belgian Companies and Associations Code, the disposal by its subsidiary, Titan Cement Company S.A. (“Titan S.A.”), of 3,689 shares of Titan Cement International S.A. (“TCI”), to eight (8) executive Titan Group employees, in the context of existing stock option plans.

The above TCI shares were sold on 19 and 21 May 2020 by Titan S.A., through OTC transactions, at an exercise price of € 10 per share (i.e. € 36,890 in total).

Following the above transactions, Titan S.A. owns 5,175,877 TCI shares, representing 6.28% of the voting rights of TCI.
