- Of Gross profit amounted to € 29.069 thousand. compared to € 30.286 thousand in 2018, decreasing by 4.02%.
- Pre-tax profits amounted to € 20.652 thousand. compared to € 20.951 thousand of the previous financial year, showing a decrease of 1.42%.
- After-tax profits amounted to € 14,658 thousand. compared to € 14.001 thousand in 2018, showing an increase of 4.70%.
- O EVIDDA profits amounted to € 25.925 thousand. compared to € 25.478 thousand of the previous financial year, increasing by 1,75 %.
- O The company has a strong cash base, with cash reserves of € 75,844 thousand. increased by 5.88%,
- The Share Capital remains unchanged at € 40,656 thousand divided into 36,300,000 shares with a nominal value of € 1.12 each.
