

## Share buy-back announcement

FOURLIS HOLDINGS S.A. announces in accordance with article 49 of Law 4548/2018, pursuant to the decision of the Ordinary General Meeting of the Shareholders dated 14.06.2019 and the decision of the Board of Directors dated 13.01.2020, that on 09/06/2020 purchased 3.000 own shares, at an average price of  $\leq$ 3,8908 per share, a total value of  $\leq$ 11.672,51.

Following the aforementioned purchase, the Company currently holds 432.654 treasury shares or 0,8319% of the total number of issued shares of the Company.
