

Share buy-back announcement

FOURLIS HOLDINGS S.A. announces in accordance with article 49 of Law 4548/2018, pursuant to the decision of the Ordinary General Meeting of the Shareholders dated 14.06.2019 and the decision of the Board of Directors dated 13.01.2020, that on 18/06/2020 purchased 1.400 own shares, at an average price of €3,9789 per share, a total value of €5.570,50.

Following the aforementioned purchase, the Company currently holds 451.095 treasury shares or 0,8674% of the total number of issued shares of the Company.
