

Notification of important changes concerning voting rights under L. 3864/2010 [02.06.2020]

Alpha Bank A.E. (the "Bank") announces, pursuant to the provisions of L. 3864/2010, that Blackrock, Inc., following a relevant notification on 01.06.2020, holds indirectly as of 29.05.2020, voting rights that correspond to an equal amount of common, registered, voting, dematerialised shares as well as other financial instruments that provide the right to acquire shares which incorporate voting rights, below the 5% threshold of the total voting rights of the Bank, excluding those held by HFSF.
