

## Share buyback announcement

The Company under the name "AS COMMERCIAL – INDUSTRIAL COMPUTER AND TOY COMPANY S.A." with the distinctive title "AS COMPANY S.A.", in accordance with article 49 of Law 4548/2018 and pursuant to the decision of the Ordinary General Meeting of the Shareholders dated on 21.06.2019 and the decision of the Board of Directors dated on 06.03.2020, announces that, on 22.07.2020, it purchased 10.000 own shares, at an average price of €1,85 per share, amounting to a total value of €18,500.00. The transaction was executed by the stock broking company "HELLENIC - AMERICAN SECURITIES S.A.", under the Share BuyBack Program. Following the aforementioned purchase, the Company currently holds 31.306 treasury shares representing 0,2385% of the total number of Company's issued shares.
