

## Share buy-back announcement

FOURLIS HOLDINGS S.A. announces in accordance with article 49 of Law 4548/2018, pursuant to the decision of the Ordinary General Meeting of the Shareholders dated 14.06.2019 and the decision of the Board of Directors dated 13.01.2020, that on 10.02.2021 purchased 12.500 own shares, at an average price of  $\leq$ 3,7604 per share, a total value of  $\leq$ 47.005,00.

Following the aforementioned purchase, the Company currently holds 618.551 treasury shares or 1,1894% of the total number of issued shares of the Company.
