### **(Notification of significant changes in voting rights)**

12 July 2021 - The Société Anonyme company «INTRACOM SA HOLDINGS» (distinctive title «INTRACOM HOLDINGS») in compliance with L. 3556/2007, as in force, and further to the notifications of Mr. Sokratis Kokkalis and of the companies “K-SYSTEMS” and “CLEARDROP HOLDINGS LIMITED” dated 12.07.2021 in relation to the voting rights of these entities on the shares of the Issuer Company, notifies the following:

On 12.07.2021 an out of stock market transfer of 18,146,780 common registered shares, with voting rights, issued by «INTRACOM SA HOLDINGS» (distinctive title «INTRACOM HOLDINGS») was made from Mr. Sokratis P.
