## **Dividend Distribution of Fiscal Year 2020**

Oreokastro, 20.7.2021

The Societe Anonyme with the title "AS COMMERCIAL- INDUSTRIAL COMPANY OF COMPUTERS AND TOYS SA" and the distinctive title "AS COMPANY S.A." (hereinafter "Company") notifies the investing public, in accordance with paragraphs 4.1.3.4 and 5.2 of the Athens Stock Exchange Regulations, as in force, that the Ordinary General Meeting of Shareholders of the Company that took place on 25.6.2021 decided to distribute a gross dividend for the fiscal year 2020 amounting to 0,08372537 euro per share, increased by the dividend corresponding to the 37,906 own shares held by the company. Please note that, according to the current tax provisions (article 64 of law 4172/2013, as amended and in force), the dividend to be distributed is subject to withholding tax of 5% (with the exception or variation of the withholding rate for Shareholders who are subject to special provisions). As a result, the net amount which will be paid to Shareholders shall amount to 0,0795391015 euro per share.

On Wednesday, July 28, 2021, the shares will be traded without the right to the above dividend (dividend entitlement cut-off day). Beneficiaries of this dividend are the registered Shareholders of the Company in the files of the Intangible Securities System (ISS) managed by the "Hellenic Central Securities Depository" on Thursday, July 29, 2021 (Record Date).

The payment of the dividend will be conducted on Tuesday, August 3, 2021 by "Eurobank S.A.", as follows:

1. Through the participants of the beneficiaries in the ISS (Banks and Stock Exchanges), in accordance with the regulations in force of EL.K.AT.

2. Especially in cases of dividend payment to heirs of deceased beneficiaries, whose titles are kept in the Special Account of their Shareholding tab in the ISS, under the management of ATHEXCSD, the dividend payment procedure will be carried out after the completion of the legitimacy of heirs, through the network of the bank "Eurobank S.A.".

Any dividends that will not be collected within 5 years, that is until 31-12-2026, will be written off in favor of Hellenic State according to article 1 of Decree 1195/1942.

After two (2) years from the payment date, i.e as of Friday 04.08.2023, payment will be conducted at the company's headquarters in Oreokastro, Thessaloniki (Ionias Street)
