

## Announcement of disposal of own shares

Brussels, 19 January 2022, 08:30 CET – Titan Cement International S.A. (Euronext Brussels, ATHEX and Euronext Paris, TITC) announces, in accordance with article 8:6 of the Royal Decree of 30 April 2019 implementing the Belgian Companies and Associations Code, the disposal by its subsidiary, Titan Cement Company S.A. ("Titan S.A."), of 985 shares of Titan Cement International S.A. ("TCI"), to three (3) executives Titan Group employees, in the context of existing stock option plans.

The above TCI shares were sold on 17 January 2022 by Titan S.A., through OTC transactions, at an exercise price of € 10 per share (i.e., € 9,850 in total).

Following the above transactions, Titan S.A. owns 1,122,057 TCI shares, representing 1.43% of the voting rights of
