

Share buy-back announcement

FOURLIS HOLDINGS S.A. announces in accordance with article 49 of Law 4548/2018, pursuant to the decision of the Ordinary General Meeting of the Shareholders dated 18.06.2021, the decision of the Board of Directors dated 04.10.2021 and the Share Buy Back Program announcement dated 23.06.2021, that on 31.10.2022 purchased 13.500 own shares, at an average price of €2,6448 per share, a total value of €35.705,00.

Following the aforementioned purchase, the Company currently holds 1.761.758 treasury shares or 3,3794% of the total number of issued shares of the Company.
