Reconstitution of the Board of Directors – Recomposition of BoD committee

Attica Bank Societe Anonyme announces that the Board of Directors at its meeting today, 07-06-2023, following the 07-06-2023 Minutes of the Board Nomination and Remuneration Committee, elected as new non-executive members of the Board of Directors Ms. Marianna Politopoulou and Mr. Riccardo Lambiris, in the place of the resigned non-executive members, Mr. Markos Koutis and Mr. Patrick Horend.

It is noted that with the election of the above, i) the conditions of article 5 of Law 4706/2020 in conjuction with the resolutions of the General Meeting of shareholders regarding the required number of independent members of the Board of Directors are met, and ii) the requirements of article 3 par.1.b of Law 4706/2020 regarding the adequate representation by gender on the Board of Directors of the Bank.

The above election is valid for the remaining term of office of the Board of Directors, i.e. until 01-09-2023, and will be announced by the Board of Directors at the upcoming General Meeting of Shareholders, as defined in the law and the Bank's articles of association.
