Announcement of regulated information in accordance with Law 3556/2007

- **11 December 2012** Hellenic Exchanges S.A. (HELEX) announces, pursuant to Laws 3556/2007 and 3606/2007, that Eurobank EFG Equities notified it on 06.12.2012 that:
