### Press release of Listings and Market Operation Committee - Athens Stock Exchange (ATHEX)

The Athens Stock Exchange, following today's session of its Listings and Market Operation Committee, approved the listing of up to 100,000 common bearer bonds of “**IDEAL HOLDINGS S.A.**” (ISIN: GRC148123CB9) on the Fixed Income Securities Trading Segment of the Regulated Market of ATHEX, as a result of the forthcoming issue of a Common Corporate Bond Loan of up to €100,000,000, on condition that the company's prospectus for the Public Offering and for the Listing will be approved by the Hellenic Capital Market Commission and the bonds' public offering will be successfully completed, according to the terms that are specifically published by the issuer.

Additionally, the Listings and Market Operation Committee of the Athens Stock Exchange, following today's session decided the transfer of the shares of the company “**AKRITAS S.A.**” (ISIN: GRS373173004), from the Surveillance Category to the **Main Market of ATHEX**, as of **Tuesday December 5<sup>th</sup>, 2023**, following its relevant request, since the reasons for the trading of its shares on the Surveillance Category are no longer in effect.

Finally, the Athens Stock Exchange, following today's session of its Listings and Market Operation Committee, approved the acquisition of a Market Making capacity for the shares of the company “**ORILINA PROPERTIES ANONYMI ETAIRIA EPENDYSEON SE AKINITI PERIOUSIA**” from the ATHEX Member “**LEON DEPOLAS SECURITIES S.A.**” and set the start date of the related obligations the day of the shares' listing in ATHEX, always taking into account the successful completion of the public offering. According to the public offering plan, this day is **Monday, December 11<sup>th</sup>, 2023**.
