PRESS RELEASE

The ASE Indices Committee approved the following changes in the composition of the Indices of the Athens Stock Exchange, as these resulted from the "Basic Rules of Indices Management and Operation". The changes will come in force as of Tuesday, November 6, 2001.

To be reminded that the new Sector Classification announced on October 25, 2001 included the new sector of BEVERAGES and the sector of "FOOD & BEVERAGES" was renamed "FOOD". Consequently, the correspondent sector index is renamed to 'FOOD PRICE INDEX' from the previous "FOOD-BEVERAGES PRICE INDEX".
