MYTILINEOS Group was established in 1990 and evolved from a family metallurgy business, founded back in 1908, to one of the leading Industrial business Groups in Greece.

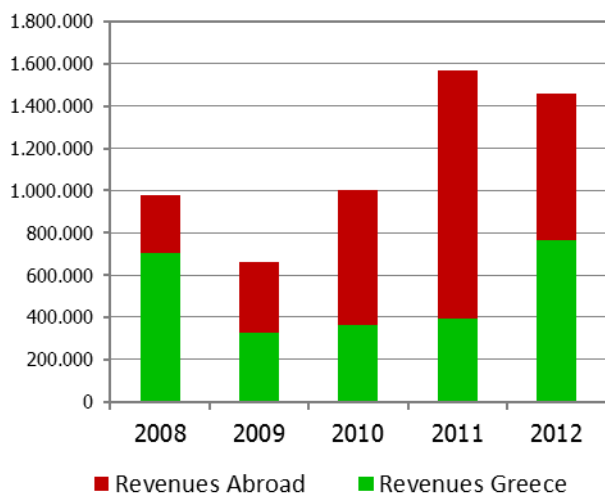
With more than 2.500 employees and a turnover that surpassed the €1.4 billion for 2012, the Group is an eminent European business Group in the sectors of Energy, Metallurgy and Construction, listed on the Athens Stock Exchange since 1995 and its share included as a constituent of the FTSE-25 large-capitalisation index.

In regards to the Construction sector, METKA S.A. is the spearhead of the Group's activity, constituting Greece's top EPC (Engineering – Procurement – Construction) Contractor, undertaking implementation of turn-key projects, and, most importantly, a competitive international player in the construction of large scale energy projects.

In the Metallurgy sector, with ALUMINIUM S.A., the Group operates the largest vertically integrated aluminium and alumina produced in the EU, along with DELPHI – DISTOMON, the second largest bauxite producer in Greece and in Europe, also a subsidiary of MYTILINEOS Group.

As far as the energy domain is concerned, in the last ten years, MYTILINEOS Group has evolved in the dominant independent power producer in Greece, with a unique portfolio of energy assets of PROTERGIA S.A., while since 2010 is also active in the supply and trading of natural gas through M&M Gas.

RECENT DEALS

03-01-2013 Alouminion S.A., a subsidiary of Mytilineos has signed with Swiss-based multinational Glencore a contract for the sale of 75,000 tons of aluminium in billets and slabs for a total price of \$200 million. These quantities will be exported to the European and U.S. markets from January 2013 to June 2014. The contract confirms the Group's strong export orientation and stresses the important role of the aluminium industry in Greece.

Mr. Evangelos Mytilineos is Chairman and Managing Director, Executive Member. He was born in Athens in 1954. He is a graduate of the Department of Economic Sciences of the University of Athens, and also holds a postgraduate degree in Economics from the London School of Economics. He is Chairman and Managing Director of MYTILINEOS HOLDINGS S.A., one of Greece's leading business Groups. He has received numerous distinctions and awards for his entrepreneurial activities, including the 'Businessman of the Year' award in 1998 from the established business magazine KEFALAIO, and the KOUROS award for Innovation and Development in 1998 from the Hellenic Entrepreneurship Association.

Mr. Ioannis Mytilineos is Vice-Chairman, Non-Executive Member. He was born in Athens in 1955. He is a graduate of the School of Engineering of the Aristotle University of Thessaloniki (Department of Civil Engineering). He is Chairman and Managing Director of METKA S.A. He was also a co-founder of MYTILINEOS HOLDINGS S.A., and has been serving as the Company's Vice-Chairman since its establishment.

Mr. George-Fanourios Kondouzoglou is Executive Member and Executive Director. He was born in Athens in 1946. He is a graduate of the Athens University of Economics and Business. He is Executive Director and a member of the Board of MYTILINEOS HOLDINGS S.A.

Ms. Sofia Daskalaki is Non-Executive Member. She was born in Buenos Aires. She studied Business Administration (Deree College, BSc) and Economics (London School of Economics). She worked, for two years in the "Short-Term Economic Forecasting Department" of the Ministry of Coordination, five years in the "Research Department" of the Bank of Greece and in 1985 joined the "MYTILINEOS Group" developing the fields of Corporate Affairs and Social Responsibility. She served from 2000 till 2010 as elected Municipal Councillor and Deputy Mayor of the Municipality of Athens. She is a founding member of the NGO, Friends of Children with cancer, "ELPIDA" and of the Network "International Transparency-Hellas".

Mr. Ioannis Dimou is Executive Member. He was born in 1960. Holds a degree from the Business Administration and Accounting Department of Athens University of Economics and Business. Is the Chief Executive Director- Finance & Operations of MYTILINEOS Group since 2005, while he has also served as Financial Director of Aluminium of Greece (2000-2005). His former positions include Chief Operating Officer of ICM Division of Frigoglass S.A. (1995-2000), Financial Director- Industrial Division and Internal Group Controller in Coca-Cola Hellenic (1989-1995). He has also worked as Internal Controller in Procter&Gamble Hellas S.A. and Controller and Business Consultant in PriceWaterhouseCoopers.

Mr. Nikolaos Mousas is Non-Executive Member. He was born in Athens in 1962. He is a graduate of the School of Law of the University of Athens, and holds a Master's degree in Law (LL.M.) from the Berkeley Law School in the USA, with specialisation in financial services law. He is registered with the Athens Bar Association since 1986 and with the Supreme Court since 1994, and is a founding partner of the "Moussas & Tsibris" Law Firm, established in 2001. He has published research papers and articles in legal journals on subjects of civil substantive and procedural law, commercial law, capital market law, stock exchange law, banking law and deposits guarantee law.

Mr. Christos Diamantopoulos is Independent Non-Executive Member. He was born in Athens in 1950. He is a Professor in the Department of Economic Sciences of the University of Athens. He is a member of the Board of MYTILINEOS HOLDINGS S.A.

Mr. Apostolos Geordiadis is Independent Non-Executive Member. He was born in Kalamata, Peloponnese, in 1935. He is a graduate of the School of Law of the University of Athens and a Professor Emeritus of Civil Law of the same School, having served in it as a Professor since 1976. He was conferred an Honorary Doctorate by the Department of Law of the Democritus University of Thrace. Is a Member of the Academy of Athens since 2000. He is an independent non-executive member of the Board of MYTILINEOS S.A.

Mr. Dimitrios Daskalopoulos is Independent Non-Executive Member. He was born in Athens in 1957. He has studied Business Administration in the Athens University of Economics and Business, and holds an MBA from the Kellogg Graduate School of Management. A member of the Board of Directors of the Hellenic Federation of Enterprises since 1999, he has served as Vice-Chairman from 2002 to 2006, and was elected Chairman in 2006. He is a member of the Board of the national bank of Greece, and a member of the International Directors' Council of the Guggenheim Museum and of the Tate Gallery. He was also a member of the European Round Table (ERT) from 1998 to 2008.

He has served as main shareholder, Chairman and Managing Director of DELTA Holding S.A., main shareholder and Chairman of VIVARTIA S.A., Chairman of the Hellenic Federation of Food Industries (SEVT) from 1999 to 2006, and a member of the Board of the Athens Chamber of Commerce and Industry from 1996 to 2000. He is currently Chairman of DAMMA Holdings S.A., a financial services and investment company.

Mr. Christos Zerefos is Independent Non-Executive Member. He was born in Cairo, Egypt, in 1943. He is a graduate of the Department of Physics and Meteorology of the University of Athens, and has carried out post-doctoral studies and research in the US National Centre for Atmospheric Research (NCAR) and in other research centres in Greece and abroad. He is Professor of Atmospheric Physics in the Universities of Thessaloniki and Athens (1973-today), and a Visiting Professor in the Universities of Boston, Minnesota and Oslo. He is a Member of the Academy of Athens, the Norwegian Academy of Sciences and Letters, Academia Europaea, and other international institutions. He is also a Fellow of the Institute of Physics (UK) and a Lifelong Member of the American Geophysical Union. Over the past three years he founded or co-founded numerous Research and other Centres. He is currently serving as President of the National Observatory of Athens.

Mr. Michael Chandris is Independent Non-Executive Member. He was born in London in 1951. He studied Economics and Political Science at the University of Lausanne. In 1975 he joined the family owned shipping business, which he's running until today. He is Chairman of Chandris (England) Ltd, Co-Founder and Director of Celebrity Cruises since 1987 and until its divestment in 1997, Vice President of the Union of Greek Ship-owners and member of the Board of Directors of the Bank of Greece.
