June 9, 2008 – Monthly Statistics Bulletin for May 2008 published by Hellenic Exchanges.

In May 2008 the Transactions Value was significally increased by 53.4% compared to previous month, reaching €10,610.95 mill. (see graph 1) from €6,917.19 mill. in April 2008. Compared to May 2007 the increase was 29.5%. In the transactions value of May 2008 is taken into account the transfer of the 20% of shares of Hellenic Telecommunications Organization (€2,548.68 mill.) from Marfin Investment Group to Deutsche Telekom.

The Average Transactions Value (monthly basis – MtD) in May 2008 was increased compared to previous month, reaching €505.28 mill. (April 2008: €345.86 mill.). Also, the Average Transactions Value (yearly basis – YtD) was increased reaching €436.16 mill.


Active Investors' Shares on May 2008 calculated to the amount of **60,993**, while the corresponding figure for April 2008 was 56,440.

Athex Market Capitalisation¹ by the end of May (30/5/2008) was €153.4 bill. (see graph 2), decreased by 6.2% compared to previous month last trading day (€163.5 bill.). This reduction is the result, to a great degree, of the delisting of 335.957.300 shares of COSMOTE MOBILE TELECOMMUNICATIONS

Deductively, the **net flows from domestic investors were positive corresponding to the amount of** €315.36 mill. having the following break down: financial institutions €55.97 mill., various legal entities €726.56 mill. Also a net outflow of €467.68 mill. derived from private individuals. The amount of €8.28 mill. which is recorded as net inflows under the category "Other Not Identified" concerns investors shares having no specific tax residence country registered by the their operators.

Foreign investors' participation in Athex by the end of May 2008 was 53.5% (graph 3). This large increase is mainly due to the delisting of shares of COSMOTE MOBILE TELECOMMUNICATIONS S.A. with market value about €8.8 bill. registered in a Greek account (Hellenic Telecommunications Organization)

The Market value of securities forming FTSE/Athex 20 reached €108.1 bill. (decreased by 1.3% compared to April 2008), FTSE/Athex Mid 40 securities reached €20.5 bill. (decreased by 1.9%) and FTSE/Athex SmallCap 80 shares €8.9 bill. (increased by 0.6%).
