

The production facilities include hatcheries, pre-fattening units, on-growing farms, packaging facilities, 1 R&D center, 2 fish feed factories, 1 fish processing factory and 1 aquaculture equipment production unit.

NIREUS S.A focuses on expanding abroad, placing particular emphasis on exports. Its top priority is to maintain the freshness and the quality of fish throughout all stages of distribution and to secure the maintenance of the cold chain. In order to better serve customers and to distribute products more effectively to Italy and to France, a sales office in Milan, Italy has been established.

Main customers include retailers and wholesalers as well as HORECA.

Company's exports represent 78.96% of total sales in 2017.




It should be noted that during the year, liquidation procedures as regards the subsidiary company MIRAMAR PROJECTS CO LTD-UK were completed on 25.07.2017




