## COMPANY PROFILE

The ELVAL Group is the aluminium product manufacturing, processing and trading branch of VIOHALCO. The extensive manufacturing base of the ELVAL Group, which includes 12 factories in Greece, Bulgaria and United Kingdom, manufactures a wide range of products including, among others, aluminum sheets for roofing, aluminum panels for doors, coils for building facades, soft drink cans, food cans, caps for spray cans, lithographic sheets, aluminum foil for household use and for food and medicine packaging.

## EXPORTS

The analysis of the Group's sales reveals that the international sales of aluminium to European Union, European countries, Asia, United States, Africa and Oceania accounted for 89.41% of the turnover in 2013.

## KEY INVESTMENT HIGHLIGHTS

ELVAL started its activities in 1973 and is now one of the most important aluminium rolling industries in the world; it is the only Group in Greece that focuses on this activity.

Some of the competitive advantages of the Group are its manufacturing flexibility, its production capability for wide coils and long slabs resulting to low production cost, its upgraded / state-of-the-art key equipment, its important presence in the lithography market, its extensive distribution network and its strategic partnerships with world-known firms.

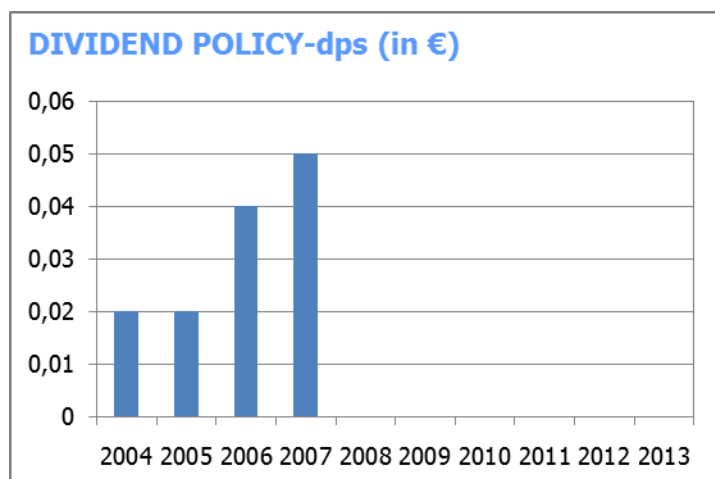

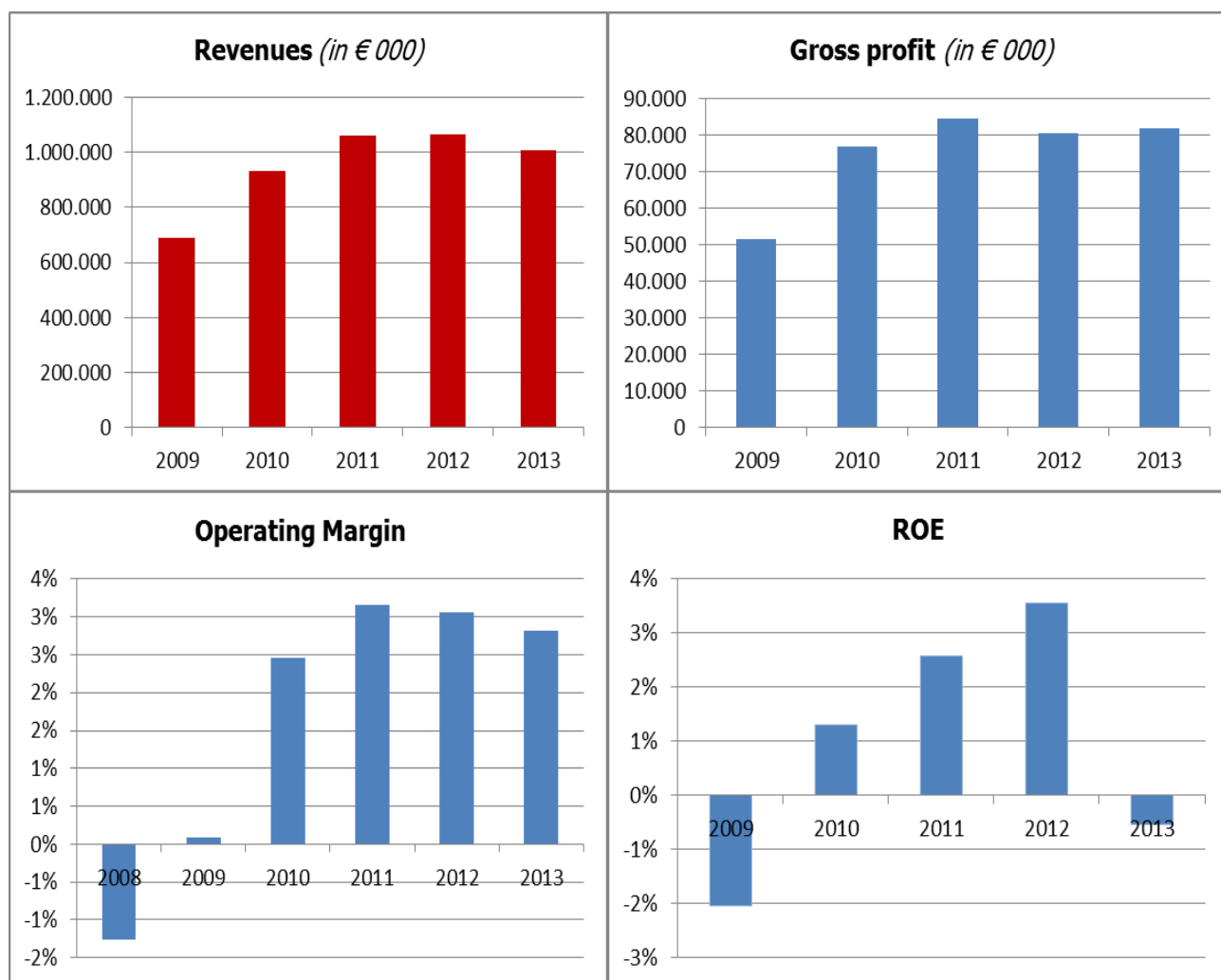

## MANAGEMENT TEAM PROFILE

**Mr. Miltiadis Lidorikis** has been Non-Executive Chairman of the Board of Directors of Elval Hellenic Aluminium Industry SA since June 11, 2008. Mr Lidorikis is a graduate of Law School of Athens University. He has served as Director of the Hellenic Development Bank (ETVA), General Manager of the National Organization of Greek Handicraft (EOEX), Vice-Chairman of the Hellenic Society of Business Administration (EEDE), Chairman of the Hellenic Society of Public Relations, Managing Director of Hellenic Exports, a subsidiary of ETVA and General Manager of XENIA S.A., a subsidiary of the Greek National Tourism Organization. He has also been a Board member of the Aluminium Association of Greece.

**Mr. Dimitrios Kyriakopoulos** has been Executive Vice Chairman of the Board of Directors since June 2007. Mr Kyriakopoulos studied Business Administration at Athens University of Economics and Business and has a degree in Business studies from the City of London College and in Marketing from the British Institute of Marketing. He started his professional career in Procter and Gamble and in 1975 he started his association with Warner Lambert assuming management posts. In 1983, after spending two years at the principal establishment of Warner Lambert in the USA as Europe Consumer Products Manager, he assumed the post of Chairman, Managing Director and General Manager of the company in Greece. Since 1985, he assumed parallel duties, at first as Regional Director of Middle East/Africa and further as Regional President of consumer products for Italy, France and Germany. During 2000-2003 he was President of ADAMS (Confectionery Division of Pfizer) for Europe/ Middle East/ Africa.. In 2004 he assumed the post of deputy managing director of KAE SA. In 2006, he became Vice-Chairman of non-ferrous metals of STEELMET SA.

**Mr. Konstandinos Katsaros** is a graduate mechanical-electrical engineer of the National Technical University of Athens; aircraft constructor/ engineer of Ecole Nationale Supérieure d' Aeronautique (Paris) and holds a PhD in Engineering of Paris University. He has been working for ELVAL since 1974 and deals mainly with the Company's international development. In the past, he had worked for 6 six years for Pechiney in France. He is a member of the Board of Directors of many Group companies; chairman and vice-chairman of the Aluminum Association of Greece and currently he is a Board of Directors' member of the European Aluminum Association.

**Mr. Nikolaos Koudounis** is Executive Director of Elval Hellenic Aluminium Industry SA. He is a graduate of Athens University of Economics and Business. He has been working for VIOHALCO Group since 1968. In 1983 he was appointed Financial Manager of Elval SA and in 2000 he was appointed General Manager. In 2004 he was appointed Managing Director of FITCO SA. He already participates as an Executive Director in the Boards of ELVAL SA, HALCOR SA, and as Chairman in the Board of DIA.VI.PE.THI.V SA and FITCO SA and other Group companies. He is also the Chairman of the Board of Mainland Greece Association of Industries

**Mr. Michael Stasinopoulos** studied Business Administration in the London School of Economics and has a master degree in Maritime, International Trading and Finance from the City University of London. He has been an executive in VIOHALCO Group since 1995, while he speaks English and French. He is a member of the General Council of the Hellenic Federation of Enterprises (SEV) and a Board member of the Greek-Japanese Chamber of Commerce.

**Mr. Andreas Kiriazis** is Non-Executive Independent Director of Elval Hellenic Aluminium Industry SA. Mr. Kiriazis is a graduate of the Chemistry Department of the Physics and Mathematics School of Athens University. He has served as Chairman of the Central Union of Greek Chambers, the Union of Balkan Chambers, the Chamber of Commerce and Industry of Athens, the Hellenic Productivity Center, the Hellenic Society of Business Administration, and the Association of Timber Industry. He has also served as Vice-Chairman of the Union of the European Chamber of commerce and Industry and General Secretary of the Union of Greek Chemists.

He works for the Viochalko Group of Companies from 1983 to 1997 as Exports Director of ELVAL SA and from 1997 to date, as a consultant to international companies of Viochalko Group as well as to ELVAL SA and Steelmet SA.

From 2005 he holds the position of the General Manager in ELVAL S.A.. He is member of Board of Directors and responsible in technical issues of subsidiary Bridgnorth Aluminium Ltd.

**Mr. Konstantinos Bakouris** has been Non-Executive Director of Elval Hellenic Aluminium Industry SA. He is member on the Board of HALCOR. He has been the Chairman of Corinth Pipeworks since 2005. He started his career in 1968 in ESSO PAPPAS. Two years later he became Financial Manager of UNION CARBIDE in Athens and six years later he became Managing Director. In 1985 he assumed the responsibility for the company's consumer products as Europe Vice-Chairman. In 1986 he was elected Chairman of Ralston Purina for Europe. In 1998 he returned to Greece as Managing Director of the Olympic Games Organizational Committee, Athens 2004. From 2001 to 2002 he was the Chairman of the Hellenic Centre for Investment (EKE). From 2004 to 2008 he also served as Chairman of NET MED N.V., the parent company of NOVA subscribers' television. He is Chairman of International Transparency Hellas and Chairman of the Greek-Russian Business Council. He has a MBA from DePaul University in Chicago.
