## **COMPANY PROFILE**

Plaisio Computers SA is a Greece-based company that assembles and trades personal computers (PCs), telecommunication and office Equipment. The Company has three main segments of operation, product categories, namely: Office products, PCs and Digital Technology products, as well as Telecommunications products. In addition the Company has two more segments, the provision of service for the PCs and the provision of transportation services, included in the category, other.

## **EXPORTS**

Its products are distributed through a network of 21 stores in Greece and 1 Bulgaria and through the direct sales, as well as www.plaisio.gr.

The Company has one wholly owned subsidiary, Plaisio Computers JSC, in Bulgaria.

Company exports are 1.2% of its total sales.

#### **KEY INVESTMENT HIGHLIGHTS**

Plaisio Computers SA is a company operating 45 years in the Geek market. It is the market leader in the market of Office Products and Technology, offering its private labels Turbo X, Q Connect, @work as well as A brand products. Employing over 1.000 people, it has achieved a CAGR of 27% in Earnings Before Taxes in the years 2008 - 2013. In 2013 Earnings Before Taxes came up to 19.4 m. € and cash and cash equivalents came up to 52.2 m. €.






