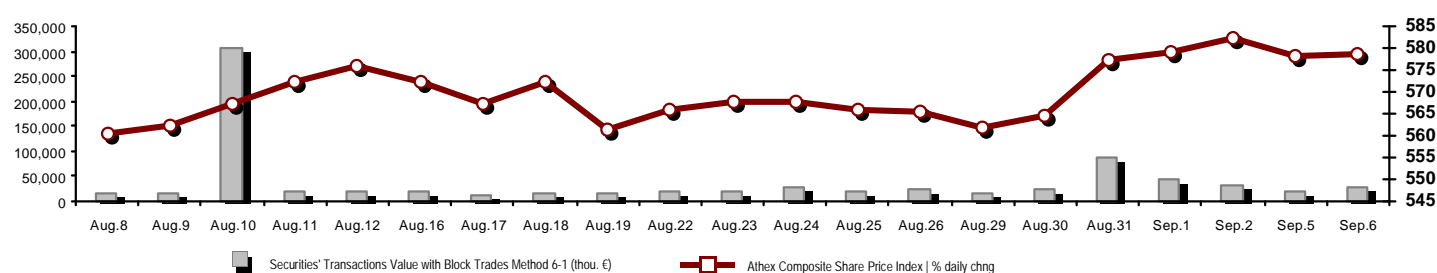

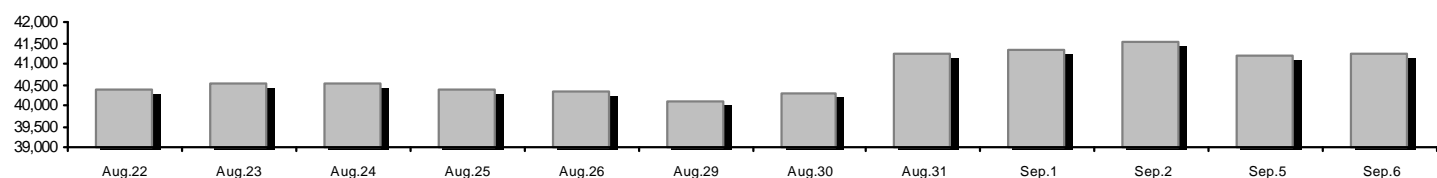

Athex Composite Share Price Index vs Shares and Derivatives Transactions Value

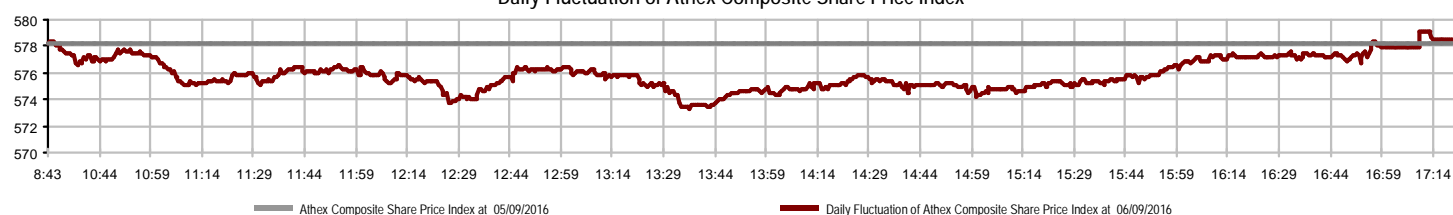

Daily Fluctuation of Athex Composite Share Price Index



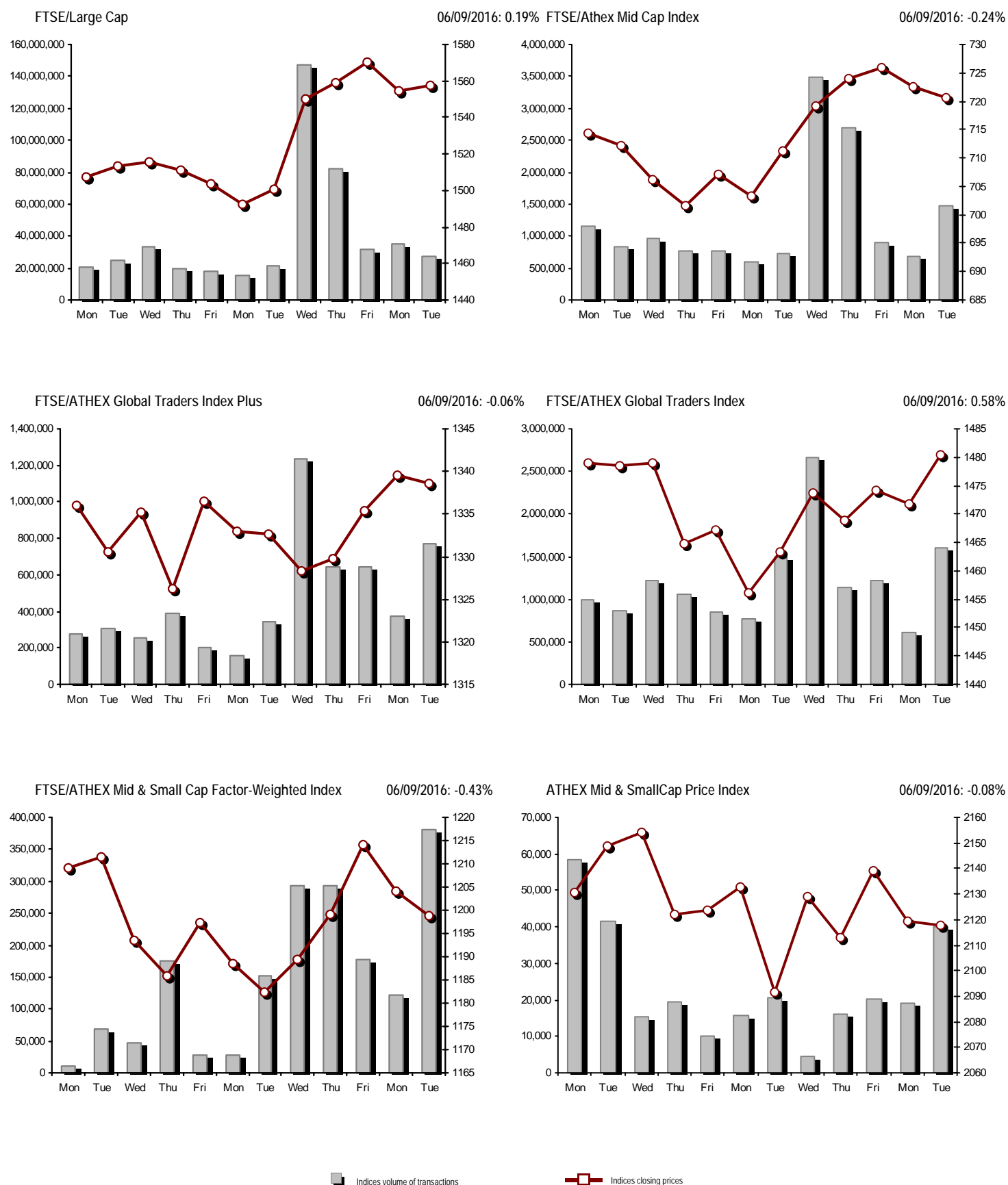
