

COMPANY PROFILE

Selonda Aquaculture SA is a Greece-based company in the marine aquaculture industry. The company's range of activities includes the reproduction, on-growing, packing, processing and commercial distribution of Mediterranean fish species, focused primarily on Sea Bream (a.k.a. "Dorade Royale" / "Orata" / "Dorada") and Sea Bass (a.k.a. "Branzino" / "Bar" / "Lubina"). Selonda is the world's largest producer of Sea Bream and Sea Bass, with an annual production of 32.000 tons and a total production capacity of 40.000 tons at 72 seacage fish farms located in Greece. The company is fully vertically integrated, as it also operates 6 hatcheries with a production capacity of 180 million fry and a fish feed plant operated by the subsidiary company Perseus with an annual production capacity of 70.000 tons of feed. Selonda is also one of Greece's top food exporters, as of over 85% of fish sales are exports to more than 20 countries around the world.

Company's exports represent 83.70% of total sales in 2017.





Mr. Athanasios Skordas, graduated from the Athens University of Economics (former AUEB) with a specialization in International Economic Relations. He was Region Central Greece General Secretary between 2006 and January 2009, when was appointed General Secretary of Tax and Custom Affairs. He was Consumer General Secretary of the Ministry of Development from March 2004 until November 2006. Since 1987 he worked as an insurance broker. He was active in the establishment and operation of financial companies and insurance interest. He was speaker of seminars related to the development and sales organization of insurance business in the Greek Institute of Insurance Studies and the Institute of Financial Studies. He has participated in numerous professional conferences in Greece and abroad, with major

domestic and international distinctions. He took oath as the undersecretary Development and Infrastructure on 21/6/2012.

Mr. Michalis Panagis is a chemical engineer with postgraduate studies in Business Administration in London, he has extensive experience having a background in management positions in major industries. For years he was head of Eurodrip group, both after the takeover by the Global Finance, and after the acquisition of the company by the US investment fund Paine and Partners.

Ms. Adamantini Lazari holds a degree in Economics from the Athens University of Economics & Business, a Master of Science in Industrial Relations and Human Resources Administration from the London School of Economics and a European Master in Multimedia and Audiovisual Business Administration (joint universities degree). From March 1994 until December 2009, she was a management consultant at Emporiki Bank, and from November 1993 until February 1999, she served as an economic advisor at the Prime-Minister's Economic Office. During the period from 2002 to 2005, she was President and CEO of EVISAK S.A., which is a subsidiary of Emporiki Group and Alpha Bank, while from July 2008 up until she assumed her duties at ATEbank she served as Director and member of the Board of Directors of the Historic Archive of Emporiki Bank. From November 2001 to March 2004 she served as a member of the BoD of ATEbank. Mrs Lazari is currently a member of the Board of Directors of ETAO (Economists' Occupational Pension Fund), while she has also served as member on the BoD of various companies, as well as member of various economic affairs committees.
