# **COMPANY PROFILE**

**REVENUE ANALYSIS (in € 000)** 

Karatzis SA is a Greece-based industrial and hotel enterprise. The Company, together with its subsidiaries, conducts business activities in the following fields: the production of polymer and synthetic fibers for agricultural, construction and industrial use; the exploitation of two hotel complexes, and the production of energy from photovoltaic parks. Under its industrial activity the company operates production units in Greece and Germany, in addition to commercial enterprises located in Spain, Italy, Russia and the United Kingdom. Its hotel activity comprises of the two hotels of the parent company, Nana Beach and Nana Princess. Under the activity of energy production from photovoltaic (P/V) parks, the Company operates P/V stations with a combined capacity of approximately nine megawatts (MW) and the P/V station of the subsidiary Karatzis Industrial & Hotel Enterprises SA & Co in the prefecture of Pieria with a capacity of approximately five MW.
