(THE "ISSUER" OR THE "COMPANY") OFFERED TO INVESTORS THROUGH THE PUBLIC OFFERING IN GREECE (THE "PUBLIC OFFERING SHARES") BY (A) THE COMPANY AND (B) AMELY S.À R.L. AND WOKALON FINANCES LIMITED (THE "SELLING SHAREHOLDERS")

The coordinators of the Greek Public Offering (as defined below), namely "Piraeus Bank S.A." and "Euroxx Securities S.A." (together the "**Coordinators**"), pursuant to Article 16 par. 3 of Law 4514/2018 and Article 8 of the Bank of Greece Executive Committee Act no. 147/27.07.2018, as well as the resolution of the board of directors of the Hellenic Capital Market Commission No. 1/808/7.2.2018, on product governance obligations, announce that, in cooperation with the Issuer they have completed the assessment of the potential target market for the Public Offering Shares, offered through a public offering in Greece (the "**Greek Public Offering**"), as follows:

- (i) The designated target market for the Public Offering Shares consists of: eligible counterparties, professional clients and retail clients, each as defined in Law 4514/2018 as in force, who have at least a basic knowledge of and experience in investment products and services and at least moderate risk tolerance, irrespective of the investment time horizon and with investment purpose of capital development, and/or income through the receipt of dividends and/or hedging.
- (ii) All channels of distribution of the Public Offering Shares (i.e., provision of investment services regarding investment advice, portfolio management, reception/transmission of transaction order and execution of transaction order) are considered appropriate for the clients of the designated target market.
