
Company Profile

The parent company and its 100% subsidiaries **ATHEXCLEAR** and **ATHEXCSD** operate the organized cash and derivatives markets, carry out trade **clearing**, **settlement** and **registration** of securities. Also, they provide comprehensive **IT solutions** as well as other **ancillary services**, promoting the developement of the Greek Capital Market.

The Group also provides support services to the **Hellenic Energy Exchange**, in which it holds a 21% stake. The Groups also holds a 0.8% stake in **Boursa Kuwait**.







Operating Cash Flow (€ mil)






Cash Distributions (€ per share, by payment year)
