Stock Markets Steering Committee of Hellenic Exchanges - Athens Stock Exchange (ATHEX)

Following the 31/10/2025 decision of the Stock Markets Steering Committee of the Athens Stock Exchange (ATHEX), and pursuant to the relevant announcements by the companies, please see below the corresponding schedule of actions regarding the derivative products—Stock Futures, Stock Options and Lending Products—on the shares of Eurobank Ergasias Services and Holdings S.A. and Piraeus Financial Holdings S.A.:

It is noted that:

- (a) For the derivative products—Stock Futures and Lending Products on the shares of **Eurobank Ergasias Services and Holdings S.A.**:
 - On Monday, 15/12/2025, as a result of the corporate action, new series of Futures with underlying EUROB shares will be traded in the trading system, distinguished from the previous trading symbols (e.g., EUROB25LX instead of EUROB25L), with all existing participant positions transferred to the new Futures.
 - The **start of trading for the Futures and Securities Lending products** with underlying shares of **Eurobank S.A.** will take place on **Monday, 15/12/2025**.

Monday, 15/12/2025	 Trading of new Stock Futures series with underlying EUROB shares, distinguished from the previous trading symbols (e.g., EUROB25LX instead of EUROB25L), with all existing participant positions transferred to the new Futures. Trading of Lending Mechanism products.

- (b) For the derivative products—Stock Futures Contracts, Options, and Lending Products—on the shares of **Piraeus Financial Holdings S.A.**:
 - On Monday, 22/12/2025, as a result of the corporate action, new series of Futures with underlying TPEIR shares will be traded in the trading system, distinguished from the previous trading symbols (e.g., TPEIR25LX instead of TPEIR25L), with all existing participant positions transferred to the new Futures.
 - The start of trading for the Futures, Options, and Lending Mechanism products with underlying shares of Piraeus Bank S.A. will take place on Monday, 22/12/2025.
 - The expiration of the December Stock Futures will be moved to Monday, 29/12/2025, in accordance with ATHEX Resolution 12, based on the closing price of the underlying value on that same day (29/12/2025).
