## Brussels, May 27, 2025

The enclosed information constitutes regulated information as defined in the Royal Decree of 14 November 2007 regarding the duties of issuers of financial instruments which have been admitted for trading on a regulated market.

Viohalco S.A. (the **Company**) announces that the Company's Annual Ordinary Shareholders' meeting, held on May 27, 2025, approved the annual accounts for the financial year ended 31 December 2024, including allocation of the results and the distribution of a gross dividend of EUR 0.16 per share.

The gross dividend amount of EUR 0.16 per share is subject to a 30% (\*) withholding tax under Belgian Law.

The record date for the beneficiaries of the dividend is Wednesday, June 25, 2025 (ex-date Tuesday, June 24, 2025). Starting date of dividend payment is Thursday, June 26, 2025, through ING Belgium.

As for the shareholders whose shares are traded on the Athens Stock Exchange and are held in the ATHEXCSD, the dividend will be paid through the DSS Operators, following the payment of the amounts from the ATHEXCSD to the latter.

(\*) The final net dividend can be differentiated, as the Belgian tax authorities impose a withholding tax and tax compliance formalities, depending on the shareholder's tax residence.
