

## **Financial Results for the Fiscal Year 2024 ATTICA PUBLICATIONS SA**

The ATTICA PUBLICATIONS S.A. Group of Companies announced the financial results for the Fiscal Year 2024 based on International Financial Reporting Standards (IFRS).

During the current fiscal year, the Group's turnover increased by 2,792.41 thousand euros (14.82%). In detail, revenue from sales of magazines and other products/merchandise through the distribution agency increased by 277.54 thousand euros (6.22%), while advertising revenue, which constitutes 73.27% of the Group's turnover, increased by 2,525.08 thousand euros (18.94%). It is noted that the change in revenue compared to the previous fiscal year has also been affected by the full consolidation of the company "DESMI PUBLISHING S.A.", with its revenue for the current period amounting to 2,334.36 thousand euros.

The Group's earnings before taxes, financial, investment results and total depreciation (EBITDA) increased by 34.99% and amounted to 3,533.92 thousand euros compared to 2,617.83 thousand euros in the previous year. The results before taxes increased by 53.65% and amounted to profits of 1,975.33 thousand euros compared to 1,285.60 thousand euros in the previous year. The net results after taxes amounted to profits of 1,419.93 thousand euros compared to profits of 1,029.69 thousand euros in the previous year. The corresponding accounts of the subsidiary "DESMI PUBLISHING S.A." for the current year amount to: profits before taxes, financial, investment results and total depreciation (EBITDA) 106.02 thousand euros, net results after taxes 94.82 thousand euros.

The turnover of the parent company increased by 392.37 thousand euros (3.12%) mainly due to the increase in advertising revenue of 447.12 thousand euros (5.77%). The Company's earnings before taxes, financial, investment results and total depreciation (EBITDA) increased by 61.51% and amounted to 2,004.77 thousand euros compared to 1,265.97 thousand euros in the previous year.

The results before taxes of the current year were burdened with an extraordinary impairment loss of subsidiaries totaling 1,001 thousand euros (compared to 513 thousand euros in the previous year), resulting in profits of 32.19 thousand euros compared to losses of 229.44 thousand euros in the previous year and net results after taxes of the current year in losses of 250.11 thousand euros, compared to losses of 191.44 thousand euros in the previous year.

Excluding extraordinary and non-recurring impairments, the results before taxes for the current year would have been in profits of 1033.34 thousand euros, compared to profits of 283.56 thousand euros in the previous year.
