

Dividend Cut-Off Date Notification / Dividend Payment for the fiscal year 2024

The Societe Anonyme "AS COMMERCIAL-INDUSTRIAL COMPANY OF COMPUTERS AND TOYS S.A." and the distinctive title "AS COMPANY S.A." with General Commercial Reg. No. 057546304000 (hereinafter "the Company") informs the investing public, pursuant to paragraphs 4.1.1.4 and 5.2 of the Athens Stock Exchange Regulation, as in force, that the Annual General Meeting of the Shareholders of the company which was held on 19.06.2025 decided to distribute a gross dividend of 0,1713121688 €/share, which has been increased by the dividend corresponding to the 100.539 treasury shares held by the Company and are not entitled to a dividend. It should be noted that in accordance with the applicable tax provisions (Article 64 of Law 4172/2013, as amended and in force), the dividend to be distributed is subject to a withholding tax of 5% (with the exception or differentiation of the withholding rate for shareholders who are subject to special provisions). As a result, the net amount to be collected on the behalf of the Shareholders will amount to 0,1627465604 €/share.

On Thursday, July 10, 2025, the shares will be traded without the right to the above dividend (dividend cut-off date). The beneficiaries of this dividend are the Company's registered Shareholders in the records of the Dematerialized Securities System (DSS) managed by the "Hellenic Central Securities Depository S.A." (ELKAT) on Friday, July 11, 2025 (Record Date).

The payment of the dividend will be made on Wednesday, July 16, 2025 by the paying bank "Piraeus Bank S.A.", as follows:

- 1. Through the participants of the beneficiaries in the DSS (Banks and Brokerage Companies), in accordance with the provisions of the Rules of Operation of the Hellenic Central Securities Depository (ELKAT).
- 2. Especially in cases of dividend payment to heirs of deceased beneficiaries, whose securities are held in the Special Account of their Tab in the DSS, under the management of ATHEXCSD, the dividend payment process will be carried out after

the completion of the legalization of the heirs, through the network of "Piraeus S.A." bank.

Dividends that will not be collected within 5 years from the end of 2025, i.e. until 31-12-2030, are time-barred (Article 250 of the Civil Code, c. 15 and 253 of the Civil Code) and are definitively attributed to the Greek State in accordance with Article 1 of Legislative Decree 1195/1942.

From Wednesday, 01.01.2027 onwards, the dividend will be paid only from the Company's offices in Oreokastro, Thessaloniki (Ionia Street).
