On 22 December 2025, AIAG acquired 219,449 ordinary shares of the Company (ISIN GRS419003009) at an average price of EUR 18.4698 per share, for a total consideration of approximately EUR 4,053,179.14. The transaction was executed on the Athens Stock Exchange and on private trading venues operated as Multilateral Trading Facilities (MTFs).
